Tentative Decisions for January 22, 2025

FL-11-00364 Perez v. Perez

Respondent's Request for Order is GRANTED as requested. Spousal Support arrears is calculated at \$1,400.00 plus \$140 in interest. Petitioner is ordered to pay arrears at a rate of \$100 each month until the arrears and interest are paid in full. Arrears is to be paid as follows: one-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month. The request for the issuance of a new Earnings Assignment Order for Spousal Support is also granted as requested.

FL-24-00132 Ruiz Perez v. Barajas

Petitioner's Request for Order for a Voluntary Waiver of Preliminary Disclosure per Family Code section 2017(b)(3) is GRANTED as requested.

FL-24-00169 Aguirre Garcia vs. Garcia

Petitioner's Request for an Order that Respondent provide complete and code compliant financial disclosures to Petitioner is GRANTED. Respondent is required to serve the Preliminary Declaration of Disclosure on Petitioner by February 21, 2025. Respondent is

also required to file with the court, no later than February 21, 2025, a declaration stating that service of disclosure documents was completed.

Petitioner's Request for Order regarding Spousal Support is GRANTED in the amount of \$1,688.00 per month. One-half of the payment is due on the first of each month and one-half of the payment is due on the fifteenth of each month.

The orders are effective on January 22, 2025.
